

DATA PROTECTION AND PRIVACY STATEMENT

SCOPE AND CONSENT

This Data Protection and Privacy Statement (the "**Statement**") outlines the practices of **Softchhet Inc.**, an entity duly registered and operating under the laws of the Republic of Panama (the "**Company**," "**we**," "**us**," or "**our**") regarding the collection, use, storage, and disclosure of personal information obtained from users ("**you**" or "**your**") of our website located at: <http://softchhet.com/> (the "**Website**") and services (the "**Services**"). By accessing or using our Website, you expressly consent to the data practices described in this Statement.

LEGAL BASIS FOR DATA PROCESSING

We process your Personal Data on the following legal grounds:

- a) Performance of a contract to which you are a party or to take steps at your request prior to entering into a contract;
- b) Compliance with legal obligations to which we are subject;
- c) Pursuit of our legitimate interests, provided such interests are not overridden by your interests or fundamental rights and freedoms;
- d) Your explicit consent, where applicable.

CATEGORIES OF PERSONAL INFORMATION COLLECTED

We may collect and process the following categories of personal information (the "**Personal Information**" and/or "**Personal Data**"):

- a) **Identity Information:** Full name, date of birth, nationality, government-issued identification details;
- b) **Contact Information:** Email address, phone number, physical address;
- c) **Financial Information:** Bank account details, transaction history, cryptocurrency wallet addresses;
- d) **Technical Data:** IP address, browser type and version, time zone setting, operating system;
- e) **Usage Data:** Information about how you use our Website and Services.

PURPOSES OF DATA PROCESSING

Your Personal Information is processed for the following purposes:

- a) To verify your identity and comply with Know Your Customer (KYC) and Anti-Money Laundering (AML) regulations;
- b) To provide and maintain our Services;

- c) To process transactions and send related notifications;
- d) To respond to your inquiries and provide customer support;
- e) To detect and prevent fraud, unauthorized access, and other illegal activities;
- f) To comply with legal and regulatory obligations;
- g) To improve our Services and develop new features.

DATA RETENTION AND DELETION

We retain your Personal Information for as long as necessary to fulfill the purposes outlined in this Statement, unless a longer retention period is required or permitted by law. Upon termination of your account, we will securely delete or anonymize your Personal Data within a reasonable timeframe, except where retention is necessary for legal or regulatory compliance.

DATA SECURITY MEASURES

We implement appropriate technical and organizational measures to protect your Personal Information against unauthorized access, alteration, disclosure, or destruction. These measures include, but are not limited to:

- a) Encryption of data in transit and at rest;
- b) Regular security assessments and penetration testing;
- c) Access controls and authentication mechanisms;
- d) Employee training on data protection and security practices.

While we strive to protect your Personal Information, no method of transmission over the Internet or electronic storage is fully secure. Therefore, we cannot guarantee absolute security.

THIRD-PARTY DISCLOSURES

We may disclose your Personal Information to the following categories of third parties:

- a) Service providers and business partners who assist in operating our website and providing our services;
- b) Law enforcement agencies, regulatory bodies, or other public authorities when required by applicable laws or regulations;
- c) Professional advisors, such as lawyers, auditors, and insurers, where necessary in the course of their professional services;
- d) Potential buyers or investors in the event of a business transaction involving the sale or transfer of all or a portion of our business or assets.

We require all third parties to respect the security of your Personal Data and to treat it in accordance with applicable laws.

INTERNATIONAL DATA TRANSFERS

Your Personal Information may be transferred to, and processed in, countries other than your country of residence. These countries may have data protection laws that differ from those in your country. We implement appropriate safeguards to ensure that your Personal Information remains protected in accordance with this Statement and applicable data protection laws.

YOUR DATA PROTECTION RIGHTS

Subject to applicable law, you may have the following rights regarding your Personal Information:

- a) Right to access and obtain a copy of your Personal Data;
- b) Right to rectify inaccurate or incomplete Personal Data;
- c) Right to erasure of your Personal Data in certain circumstances;
- d) Right to restrict processing of your Personal Data;
- e) Right to data portability;
- f) Right to object to processing based on legitimate interests;
- g) Right to withdraw consent where processing is based on consent.
